Treasurer's Report 2017

The funding required for the operation of the Society comes from three sources: the Maple Ridge Historical Society earned funds, the Operating Grant from the City of Maple Ridge and from successful grant applications.

Grants continued to provide the Society with funds to extend its activities through the summer student funding from Young Canada Works and Human Resources Canada programs and a Community Gaming Grant from the province of British Columbia. The addition of the 2017 Library and Archives Canada grant supported the documenting and some scanning of the Times Newspaper negatives that were donated by the Black Press Group in 2015.

Based on a carefully prepared budget, all financial matters are reconciled monthly and reported to the Board through quarterly reports which allow the board members to review the status of each budget category. The preparation of these reports is carried out by our Executive Director, Val Patenaude who also monitors the work of our accounting service provider, Luba King.

During the year, the financial committee work was carried out by the Board of Directors at their monthly meetings.

As a Registered Society with a Charitable Tax endorsement, we are subject to an audit by the governing authorities at any time. The financial management system, along with the support of Luba King and the excellent work of our Executive Director, allows us to stay "Audit Ready".

The Society had \$3,800 in infrastructure expenses this year for the heritage church hall and the money will be drawn from our funds restricted to that purpose. The balance remaining from funds budgeted for our other buildings but not spent will be added to those restricted funds to provide for future projects.

Thanks to the members of the Board, Val Patenaude and staff.

Notes to Financial Statements

I	The Expansion funds have been combined with the UWC republication fund and our infrastructure funds as "restricted funds". These funds are separate from our retained earnings and for a period of 3 years, which is renewable, the money can only be spent for the specified purposes.
2	In 2017, we were given a Library and Archives Canada grant for \$14,773 to be spent from Sept of 2017 to March of 2018. This amount is the amount spent in 2017.
3	Income in this grant category actually increased over last year, however, an extension of the YCW contract through the fall meant that the final payment of \$5,016 was not received until well into 2018 and will be included with 2018 funding.
4	There was no paid research work in 2017 as all our external research was done for the City of Maple Ridge.
5	This income category shows funds raised and used for the TIMES negative project. The 2016 funds came from the Maple Ridge Community Foundation for equipment and supplies while the 2017 funds came from a grant from Library and Archives Canada.
6	New furniture was purchased for the St Andrews Heritage Church Hall this year - tables and chairs. There was \$1250 used from the annual infrastructure budget with the balance coming from the restricted funds earmarked for infrastructure.
7	Substantial increases in BC Hydro rates resulted in cost overruns of around \$1,000 each for the heritage church and the museum buildings.
8	Memberships formerly in the name "Maple Ridge Museum" have been changed to "Maple Ridge Historical Society" with the cost being moved to the MRHS account.
9	The increase in the city operating grant allowed for the hiring of an additional staff person for 3 days per week plus an amount for benefits for the permanent staff.
10	The advertising and display accounts for the Maple Ridge Museum and Haney House have been given their own categories.
П	The contingency amount reflects the expenditure of over \$5,500 on wages for a grant program whose funds were not received until 2018.
