### **Treasurer's Report 2019**

The funding required for the operation of the Society comes from three sources: the Maple Ridge Historical Society earned funds, the Maple Ridge Historical Society Operating Agreement with the City of Maple Ridge and from successful grant applications.

Grants continued to provide the Society with funds to extend its activities through the Community Gaming Grant of \$24,000 and the summer student funding from the Young Canada Works and Human Resources Canada programs of \$13,087.

Staff introduced new programs at Haney House including Murder Mystery evenings and a Halloween Paranormal event, all of which were well attended, providing additional revenue.

Based on a carefully prepared budget, all financial matters are reconciled monthly and reported to the Board through quarterly reports which allow the board members to review the status of each budget category. The preparation of these reports is carried out by our Executive Director, Val Patenaude who also monitors the work of our accounting service provider, Luba King.

During the year, the financial committee work was carried out by the Board of Directors at their monthly meetings.

As a Registered Society with a Charitable Tax endorsement, we are subject to an audit by the governing authorities at any time. The financial management system, along with the support of Luba King and the excellent work of our Executive Director, allows us to stay "Audit Ready".

The Society continues to develop the infrastructure program. The balance remaining from funds budgeted but not spent will be added to those restricted funds to provide for future projects.

Thanks to the members of the Board, Val Patenaude and staff.

# **Maple Ridge Historical Society**

Notes to Financial Statements

1	The Expansion funds have been combined with the UWC republication fund and our infrastructure funds as "restricted funds". These funds are separate from our retained earnings and for a period of 3 years, which is renewable, the money can only be spent for the specified purposes. This year, these funds were drawn on to pay for the electrical upgrade of the Old Post Office preschool.
2	The apparent variation in amount received for memberships each year is due to the fact that most renew over the year end and the total reflects in which calendar year the renewal was paid.
3	Income in this grant category can fluctuate widely. In 2018, an extension of the YCW contract through the previous fall plus getting four student salaries is reflected by the larger amount. In 2019, we only received 3 student salaries and no extensions.
4	This category got a big boost in 2018 from the Ocean Spray cranberry commercial production which engaged our staff for research and monitoring and then took over the museum for a day.
5	Substantial increases in BC Hydro rates coupled with a very high bill for the cold months led to an extremely high church utilities bill in 2017.
6	The apparent variation in amount spent on memberships each year is due to the fact that renewal payments span the year end and the total reflects in which calendar year the renewal was paid. This includes the CMA, BCMA, Heritage BC, Archives BC and BC Historical Federation.
7	Project funds come from a variety of sources for specific programs or projects. In 2019, projet funds were provided by the MRHS to the museum for renewal and renovation of the website.
8	There has been a dramatic increase in costs for storage. There has been another big jump for 2020.
9	The increase in contingency funds this year are due to new rentals at St Andrews Heritage Church, particularly regular rentals by St John Ambulance for classes.
